APPLICATION FOR "PAY AND RIDE" PROGRAM

I understand that the cost per child is \$360.00 per year and payable, in full, **no later than Friday, June 29, 2012** to be eligible for a bus. **Please complete a separate form for each child.**

By signing this application, as parent/guardian of the above name child, I agree to and will abide by the Stoughton Public Schools Transportation Policies and Guidelines. These are available at www.stoughtonschools.org and at each school's office.

I qualify for a fee waiver under the federal low-income guidelines as a free and/or reduced lunch applicant. I have enclosed the required documentation. (No waiver of fees will be processed without the proper documentation.) This form does not replace the Food Service Department required documentation.

MASTERCARD, VISA, DISCOVER, BANK CHECKS, MONEY ORDERS OR CASH WILL BE THE ONLY FORMS OF PAYMENT ACCEPTED BY STOUGHTON PUBLIC SCHOOLS. NO PERSONAL CHECKS WILL BE ACCEPTED. (Adopted by the School Committee, April 2004)

Credit cards (MasterCard, VISA, Discover) can be used to pay bus fees starting on Monday, May 7, 2012 through Friday, June 29, 2012 *ONLY*. *Credit card payments will not be accepted after June 29, 2012*. To make payment with a credit card go to: www.mealpayplus.com. **PLEASE NOTE THAT MEALPAY CHARGES A FEE OF 4.29% FOR EACH TRANSACTION.** To pay by credit card you will need to have your child's Local Assigned Student Identification Number (LASID). **When paying by credit card you MUST also fill out a Pay & Ride application and submit it to your child's school.** For grades 6 through 12, the LASID number is on your child's report card, for elementary students the LASID number can be obtained from your child's school office.

PLEASE NOTE: ONCE THE "PAY AND RIDE" BUS IS ADDED, THERE WILL BE NO REFUNDS.

Application cut-off date is June 29, 2012. The district will again accept applications for available seats starting on September 5, 2012. Any applications submitted after the June 29th deadline will depend on availability and will be determined after the start of the school year.

Secondary students must have a pass in order to ride the bus. If a student does not have a pass, they will be given one day to acquire a new or temporary pass. On the second and subsequent days, if the student still does not have a pass, they will not be allowed to ride the bus. Replacement passes are available at the administrative office of your child's school for a fee of \$2.00.
